The Cyber Fraud Report 2024 by Grant Thornton Bharat.

In 2024, India witnessed several high-profile banking and finance scams. The Financial and Cyber Fraud Report 2024 by Grant Thornton Bharat revealed a significant upswing in fraud post-pandemic, with every second organization surveyed encountering one or more fraud incidents. Cyber incidents, diversion of assets, and regulatory fraud were identified as key areas of fraud. Moreover, the report highlighted the low adoption of anti-fraud technology, with only around 20% of organizations using advanced predictive detection capabilities. Cyber fraud dominated industries, constituting 64% of incidents, following transformative changes in business operations post-pandemic.

# Air India's Bold Rebirth: A Journey of Transformation

#### Overview:

In 2022, Air India was acquired by the Tata Group, marking the beginning of a major overhaul to regain its leadership in the aviation industry.

#### Cause & Effect:

Years of mismanagement led to a steep decline in market share to 8.4% by 2022, impacting service quality and customer confidence.

## Company's Action:

Fleet Expansion: Order of 470 new aircraft worth \$70 billion.

- -Vistara Merger: Strengthening full-service offerings and expanding routes.
- -Digital & Staff Growth: Investing in IT and hiring 3,800 employees..

## Key Takeaway:

Air India's recovery strategy is centered on fleet modernization, digital upgrades, and enhanced customer service, with the goal of capturing 30% of the domestic market share by 2027

## Financial concept

### 1) Net Worth

It's the total value of everything you own (assets) minus what you owe (liabilities). If you own a house worth ₹50 lakhs, have ₹10 lakhs in savings, and your car is worth ₹5 lakhs, your total assets are ₹65 lakhs. With liabilities of ₹35 lakhs, your net worth is ₹30 lakhs.

## 2) Emergency Funds

This is money saved for unexpected costs, like medical emergencies or car repairs. It's best to have three to six months' worth of living expenses saved up in this fund. For monthly expenses of 30,000, aim for an emergency fund of 90,000 to 1,80,000

## Storytime IPL 2025 Mega Auction: Historic Bids and Shifting Strategies

The IPL 2025 Mega Auction, held in Jeddah on November 24-25, set new records with major signings and a shift toward younger talent. Rishabh Pant was the top pick, bought by Lucknow Super Giants for ₹27 crore, the highest bid in IPL history. Other key acquisitions included Shreyas Iyer (₹26.75 crore by Kolkata Knight Riders) and KL Rahul (₹14 crore by Delhi Capitals). The auction also saw iconic returns, such as Ravi Ashwin rejoining Chennai Super Kings, and franchises focusing on both star players and promising domestic talents like Venkatesh Iyer and Jos Buttler.

On Day 2, teams filled out their rosters with impactful players, including Bhuvneshwar Kumar (₹10.75 crore by Royal Challengers Bangalore) and young prodigy Vaibhav Suryavanshi (₹1.1 crore by Rajasthan Royals). Veteran players, including David Warner, went unsold, reflecting the shift towards youth. The auction concluded with a record ₹639.15 crore spent on 182 players, including 62 overseas talents, setting the stage for a thrilling IPL 2025 season. The IPL 2025 Mega Auction has not only reshaped team compositions but also set the tone for an exciting and unpredictable season ahead.
